**ANVS Night Vision Goggles (NVG)** 

#### Overview

L3 Technologies Inc., Insight Technology Division ("L3 Insight") has recently become aware of a condition that may affect operation on a small percentage of ANVS Night Vision Goggles (NVG). The condition is limited to specific deliveries beginning April 2016 through July 2018.

## **Product Description**

NVG are head-mounted binocular imaging assemblies that provide the pilot with an image intensified view of the existing scene outside the aircraft in night visual meteorological conditions.

## **Description**

If the condition is present in any of these units, the Operator may notice the Image Intensifier tube operate intermittently, and/or flicker. The condition, though reported to have occurred in product containing

White Phosphorus tubes, may also exhibit the noted performance in product produced with Green Phosphorus tubes. The intermittent operation and/or flickering could occur in either the left or the right monocular.

<u>NOTE</u>: This is a limited and anomalous condition expressly restricted to the April 2016 through July 2018 deliveries; it has not been seen in any ANVS 245084-XXX units delivered prior to that time; and it has been corrected for all subsequent deliveries starting in August 2018.

#### **Recommended Actions**

- 1. If the condition is observed, please contact the L3 Insight Customer Service Representative to coordinate a Return Material Authorization Number via phone at 866-509-2040 (Option 3) or via email at Field.Returns@L3Harris.com for a return/repair at no cost to you.
- 2. End-user may want to consider for any or all of the part numbers of interest delivered from the timeline identified above, to utilize the goggle's next scheduled 180-day Inspection, to plan for and return available product to L3Harris for the requisite screening, and repair as necessary.
- 3. Alternatively, you may also choose to contact L3 Insight Customer Service to coordinate the return of the referenced part and serial numbers that fall within the timelines above, at any time.
- 4. L3Harris further recommends users of the ANVS 245084-XXX comply with the guidance and requirements stated within the ANVS Operators Manual ANV-TM-FAA Dated 3 October 2016. Including, the Operator must perform their Before and After Checks, if any defects are noted, it is recommended that the ANVS NVG is turned into an L3Harris authorized Part 145 Repair Station. Direct excerpt from the Operator Manuals in section 5.4.2 Inspection Criteria for Proper Image Intensifier Operation. *Flashing, Flickering, or Intermittent Operation*. This instability can occur in either one or both monocular. The unit is considered rejectable if this condition exists. Refer to Table 6-1, Troubleshooting, Intermittent Operation, for corrective action.
